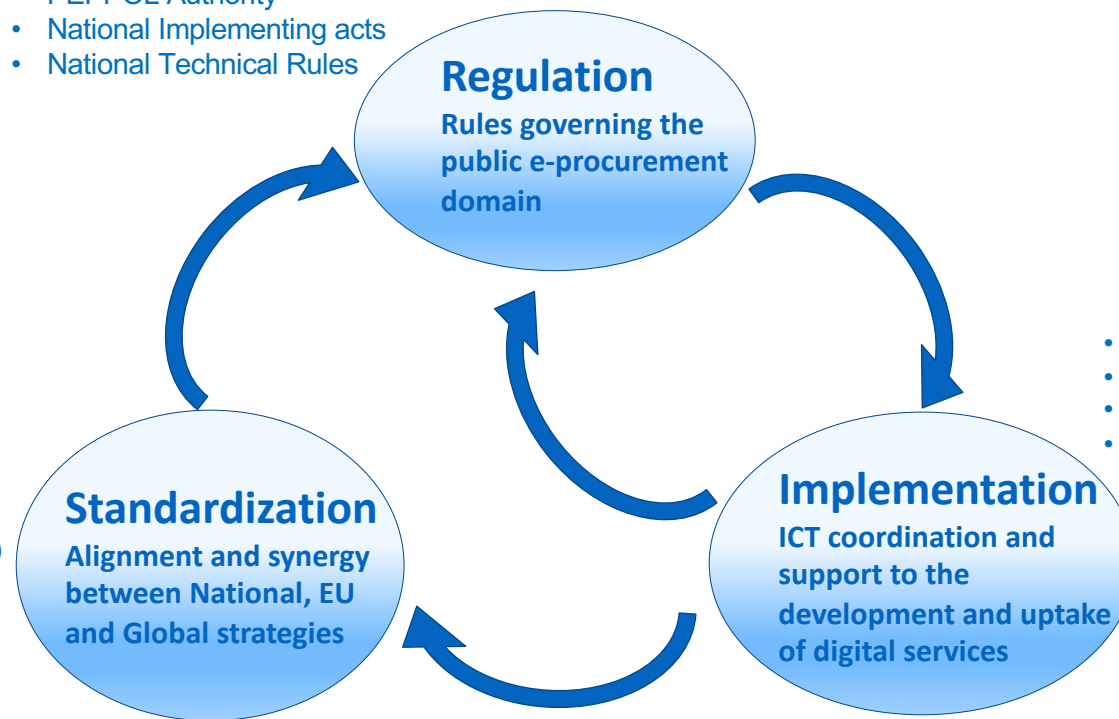

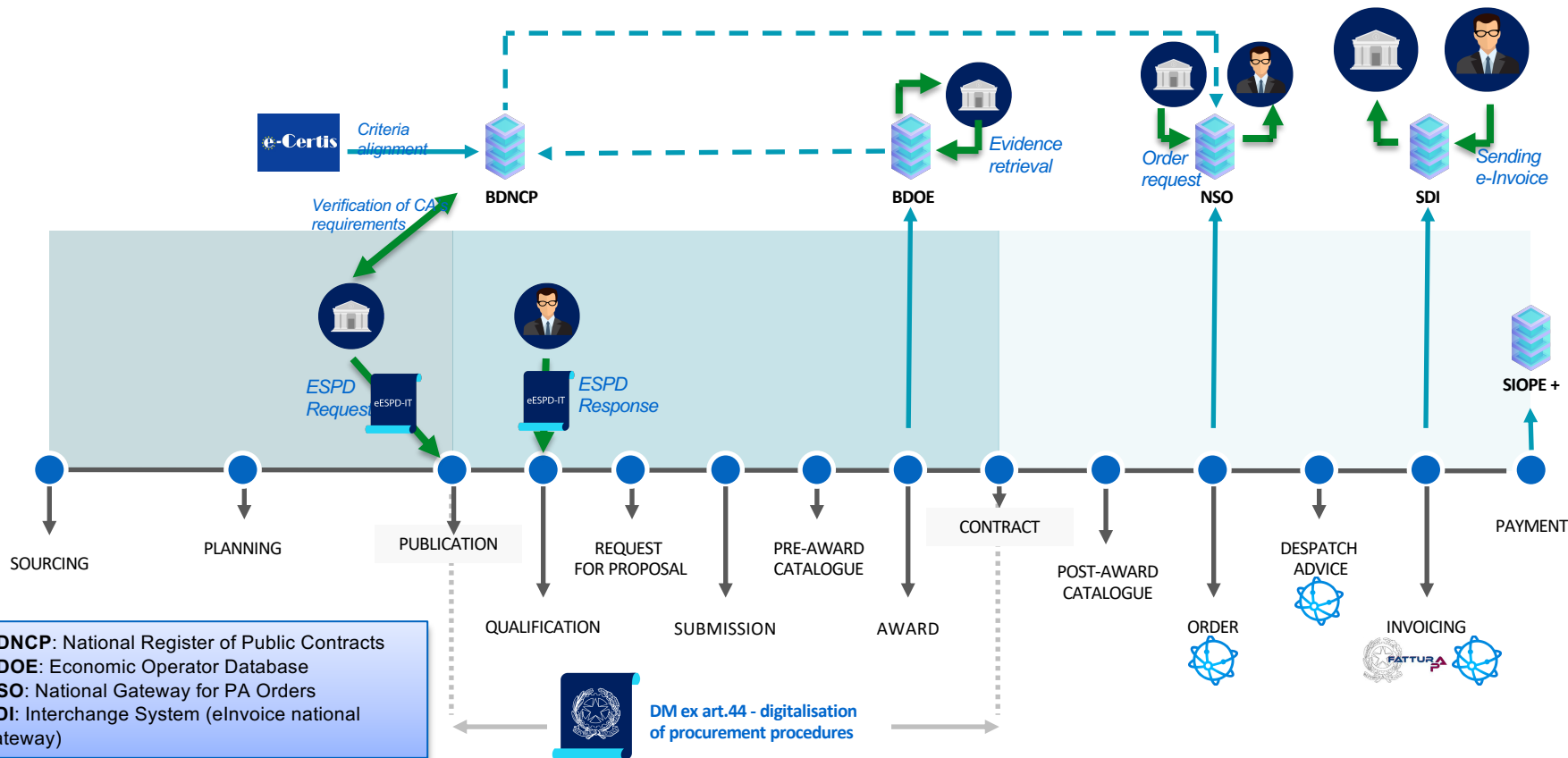

To repair the damage of the crisis and prepare a better future for the next generation, the Commission proposes a new recovery tool: **Next Generation EU**.
A fundamental policy is the strengthening of the **Digital Single Market** and to do this, priority will be given to the digitization of public procurement, also through the development of national e-procurement systems and platforms.

ANAC: launch of the **National REST eCERTIS service and ESPD gateway** financed by CEF Project ENEIDE.



AgID: publication of the "**Technical Rules** for the implementation of the Italian electronic **ESPD**"



ANAC: launch of the **Public Procurement Open Data** portal and **Analytics**. All Contract register data are available in open format and can be consulted through an analytics dashboard.



ANAC: planned date for the launch of the **eSender** in order to implement a single process for publication of tenders and contract award notices on TED, on the National Contract Register and on the ANAC Publication Portal in OCDS format. (CEF project ENEIDE).



AgID, ANAC: early adoption of **eForms** as the elective format for procurement data collection and publication.



AgID: publication of technical rules on the digital transformation of awarding procedures laid down in the Public Contracts Code.



National Multi-stakeholder forum on e-invoicing: announcement that gap for domestic invoicing between EN16931 and FatturaPA will be addressed by using extensions, if necessary.



WG of UNI/CT 522 eBusiness and Financial services: approval of the first stable version of national CIUS and extensions. AgID (PEPPOL Authority for IT) starts the work for defining PEPPOL BIS Billing 3 IT.



Revenue Agency : planned date for enacting national regulation updating the current Italian CIUS.



Revenue Agency : planned date for updated SDI (Interchange System -eInvoice national gateway) go live supporting the new CIUS and extensions.



AgID (PEPPOL Authority for IT): funding the national PEPPOL Access Point for PA systems. The first national system using the AP is NSO (national node for the exchange of e-orders).



AgID, Ministry of Economy and Finance : starting of the e-ordering mandate in national health system supplies. National PEPPOL AP supports about 60% of the exchanged orders.

Governance

- ✓ «Cabina di Regia» is the steering committee that is responsible for the implementation of the eProcurement strategy according to the Italian Public Contract Code (art. 212, Legislative Decree n.50/2016)
- ✓ Continuous changes in the legislative framework and the frequent amendments lead to continuous adjustments and revisions of the systems

Implementation related issues

- ✓ Possible delays and redistribution of competencies with subsequent impact on data and process responsibility
